NOTES

The occupier of a property listed in question 3, in a settlement appearing in a billing authority's rural settlement list is entitled to rate relief if it is the only such property of that type in that settlement and its rateable value is £7,000 or less changing to £8,500 with effect from 1st April 2010 (£10,500 in the case of a Public House and Petrol Filling Station, changing to £12,500 with effect from 1st April 2010.). Relief is given at 50% of the full rates bill, or of the transitional charge, if transitional arrangements apply. Billing authorities have discretion to remit all or part of the remaining 50%.

Authorities also have discretion to remit all or part of the rate bills on other properties in a settlement on the rural settlement list if the rateable value is £14,000 or less, changing to £16,500 with effect from 1st April 2010, and the authority is satisfied that the property is used for a purpose which benefits the local community.
