Council staff have inspected the site (18<sup>th</sup> May 2023) to determine the appropriateness of the proposed works to the tree**s and their** ongoing amenity.

The Council of High Peak Borough Council gives NOTICE that consent is REFUSED.

#### **Reasons for Refusal**

1. Whilst trees have been removed from the non-prevailing wind side of the tree, the rest of the tree's environment remains the same. The tree appears to be in good health and largely good structure, given the environment it grew up in.

The tree provides excellent levels of amenity to the local area and is a strong arboricultural feature neighbouring the Public Right of Way (improved by the removal of the neighbouring trees).

As the tree has not been shown to be either in poor condition or been proven in causing significant structural damage, High Peak Borough Council refuses consent to remove it.


